LOOKING BACKWARDS, LOOKING FORWARDS: ANGLO-POLISH LEGAL RELATIONS AFTER BREXIT Conference in honour of the life and work of His Hon George Dobry CBE QC

Abstract: A ½ day conference reflecting on the past and present contributions to Anglo-Polish legal relations of George Dobry's legal projects, and discussing further opportunities and difficulties following Brexit. Each participant will discuss a substantive law issue that will impact on Anglo-Polish relations post-Brexit, and also explain how George Dobry or one of the Dobry projects (i.e. the British Law Centre ["BLC"] and Slynn Foundation) impacted on their own lives or professional experience.
